

Announcement of the Ministry of Public Health (No.6), B.E.2540 (1997)
Subject: Appointment of officials to be in charge of the Non-Smokers' Health Protection Act, B.E.2535

Translation

By virtue of the power vested by the provisions of Section 3 and Section 15 of the Non-Smokers' Health Protection Act, B.E.2535, the Minister of the Ministry of Public Health hereby prescribes the announcement as follows:

Article 1

The Announcement of the Ministry of Public Health, Subject: Appointment of officials to be in charge of the Non-Smokers' Health Protection Act, B.E.2535 dated 24 July B.E.2535 (1992) shall be repealed.

Article 2

Article 3

The following officials of the provincial or central administration stationing in provincial areas shall be the officials in charge of the Non-Smokers' Health Protection Act, B.E.2535 only within their jurisdiction.

- (2) Directors of Regional, General and Community Hospitals

- (3) Directors of Regional Environmental Health Centers and Directors of Regional Health Promotion Centers
- (4) District Health Officers
- (5) Pharmacists of Provincial Health Offices
- (6) Pharmacists Class 5 up of Regional, General and Community Hospitals
- (7) Public Health Technical Officers Class 5 up of Provincial Health Officers, Regional, General and Community Hospitals
- (8) Health Promotion Technical Officers Class 5 up of Provincial Health Officers, Regional, General and Community Hospitals
- (9) Sanitary Technical Officers Class 5 up of Provincial Health Offices, Regional, General and Community Hospitals
- (10) Health Education Technical Officers Class 5 up of Provincial Health Officers, Regional, General and Community Hospitals
- (11) Health Promotion Technical Officers Class 5 up of Regional Health Centers, Department of Health
- (12) Sanitary Technical Officers Class 5 up of the Regional Environmental Centers, Department of Health

Article 4

The following officials of Ministry of Education and Ministry of University Affairs shall be the officials in charge of the Non-Smokers' Health Protection Act, B.E.2535 (1992) only within their jurisdiction.

Article 5

The following officials of the Ministry of Interior shall be the officials in charge of the Non-Smokers' Health Protection Act, B.E.2535 only within their jurisdiction

- (1) Provincial Governors
- (2) District Officers
- (3) Deputy District Officers acting as Chiefs of Sub-District Offices

Article 6

The following local administration shall be the officials in charge of the Non-Smokers' Health Protection Act, B.E.2535 only within their jurisdiction.

- (1) Bangkok Governor
- (2) Deputy Bangkok Governor, Public Health Affairs
- (3) Permanent Secretary for the Bangkok Metropolitan Administration (BMA)
- (4) Deputy Permanent Secretary for the BMA
- (5) Director, Department of Medical Services, BMA
- (6) BMA Hospitals Directors

- (7) Director, Department of Health, BMA
- (8) Health Center Directors, BMA
- (9) Director, Environmental Health Division, BMA
- (10) Director, Drug Abuse Prevention and Treatment Division Department of Health, BMA
- (11) Director, Department of Education, BMA
- (12) BMA School Directors
- (13) Director, Department of Law Enforcement
- (14) District (Khet) Directors, BMA
